

ASPEN'S AND CARSON'S DREAMS CAME TRUE

Aspen is a beautiful two-year-old German Shepherd mix that arrived at our Downey Animal Care Center

with a displaced fractured radius and ulna. Because of the displacement, Aspen required surgery to repair the fractures. The Foundation's Dreams Come True fund paid to send Aspen to a private veterinarian so she could receive the treatment she needed. Aspen is now recovered and living her best life.





Carson is a striking one year old Cattle Dog mix that was brought to our Palmdale animal care center by a Good Samaritan. Carson had likely been hit by a car and had an injured hip. Veterinary examinations determined that he needed femoral head ostectomy surgery to repair his injuries.

The Foundation's Dreams Come True fund paid for Carson to get his surgery. He was later transferred for adoption to our Agoura animal care center, where he was adopted into a loving home by Jim, Nancy, and Casey. Grandma Jackie also adores him — Carson is cherished by three generations of family members!

PETCO LOVE GRANT AWARD

Petco Love has provided a generous grant award of \$96,000 to the Los Angeles County Animal Care Foundation. The grant funds will support the Foundation's Care Voucher program, a public assistance program that offers pet food and supplies, basic veterinary services, and other critical resources for pet owners at no or low cost. This program ensures that pets in need receive the care and resources they require, while not separating them from the families they love merely for temporary financial constraints.

The Care Voucher program has prevented the surrender of hundreds of pets due to one-time financial constraints. The main reason for issuing the Care Voucher is the need for basic veterinary services such as care for teeth, skin, or gastrointestinal issues. Without the availability of these services, many pet owners would have no option but to surrender their pet to a care center. Vouchers can be requested by any pet owner who resides within unincorporated Los Angeles County and most of the 45 cities served by DACC.

Vouchers have a value of up to \$500, but not every procedure requires the full amount of the voucher. For those situations where the costs exceed the \$500, we see pet owners making up the difference with their limited funds or even placing the balance on Care Credit. Clearly, these animals are loved and their families do everything they can to keep them in the family.

By providing this intervention service, fewer animals are relinquished to DACC's care. DACC can then focus its attention on animals in its care with no families, providing more advanced medical treatment, behavior modification, and adoption opportunities for these pets. We encourage our donors to contribute to this worthy endeavor to elevate and protect the well-being of animals in our community.



The Los Angeles County Animal Care Foundation is an independent 501(c)(3) charitable foundation that supports the animals served by the County of Los Angeles Department of Animal Care and Control. 8,000 KITTENS SAVED AND COUNTING!



DACC's Pee Wee kitten foster program, which began in 2016, has now saved more than 8,000 underage kittens that would otherwise be euthanized due to lack of maternal care.

DACC is regularly contacted by well-meaning people who have found a litter of young kittens that cannot yet eat on their own and wish to bring them to the animal care center for care. However, this is not always the best option for the kittens. There may be a mother caring for them, and it is better for them to remain with her until they are weaned. Bringing unweaned kittens to an animal care center may expose them to viruses carried by asymptomatic adult cats that the kittens' underdeveloped immune systems cannot fight. Care centers do not have the staff to feed unweaned kittens every few hours, around the clock. Therefore, these kittens may be euthanized if a foster home cannot be found for them. If the kittens appear clean, healthy, and have full bellies then their mother is caring for them and intervention is not necessary until they are weaned, at which time they should be spayed or neutered and placed into new homes.

If the kittens appear to be thin, ill, and unclean then the mother may have become injured or otherwise unable to care for them. In these cases, the kittens need help but there is still a better option than bringing them to an animal shelter. DACC has a foster care program for residents who wish to save a litter of kittens. The Foundation pays for all the supplies necessary and DACC provides training and advice along the way. Many kind people have taken in litters of kittens for the few weeks necessary until they are old enough for adoption, and even participate in finding homes for the kittens.

A supplemental kitten foster care program has been made possible by the generous support of the American Society for the Prevention of Cruelty to Animals (ASPCA). The ASPCA began working with us on our Pee Wee kitten program in the autumn of 2016. The ASPCA has an intervention program at our Downey and Baldwin Park Animal Care Centers (ACCs) where they provide registered veterinary technicians (RVTs) to evaluate each litter of kittens and refer them to foster homes that day. The RVTs works out of DACC's Ani-Safe trailers, which are fully operational animal care mobile trailers that can house staff and animals during emergencies or other off-site needs.

Public-private partnerships like the Pee Wee program show that collaboration and good stewardship make a difference in animals' lives.
