Where There's a Will, There's a Way ...

A planned gift in a will can take the form of cash, stock, bonds, real estate, personal property, or other assets.

A planned gift is generally defined in one of three ways:

- A specific percentage of your estate
- A specific dollar amount
- A specific item (i.e., real estate, a painting, or a vehicle)

Other Opportunities For Legacy Giving

A will is the most commonly used method for making a planned gift at death. Other opportunities do exist, however, which may be used in combination with a will or as a stand-alone vehicle.

The Los Angeles County Animal Care Foundation can be named as the beneficiary on a "payable on death beneficiary" of your:

- Trust
- Retirement plan
- Life insurance policy
- Financial accounts
- Cash accounts

The Los Angeles County Animal Care Foundation would be happy to assist you and your attorney in developing a charitable giving strategy that best fulfills your charitable intentions. We offer the following sample language as a convenient starting point:

Planned Gift of a specific percentage:

Planned Gift for a specific dollar amount:

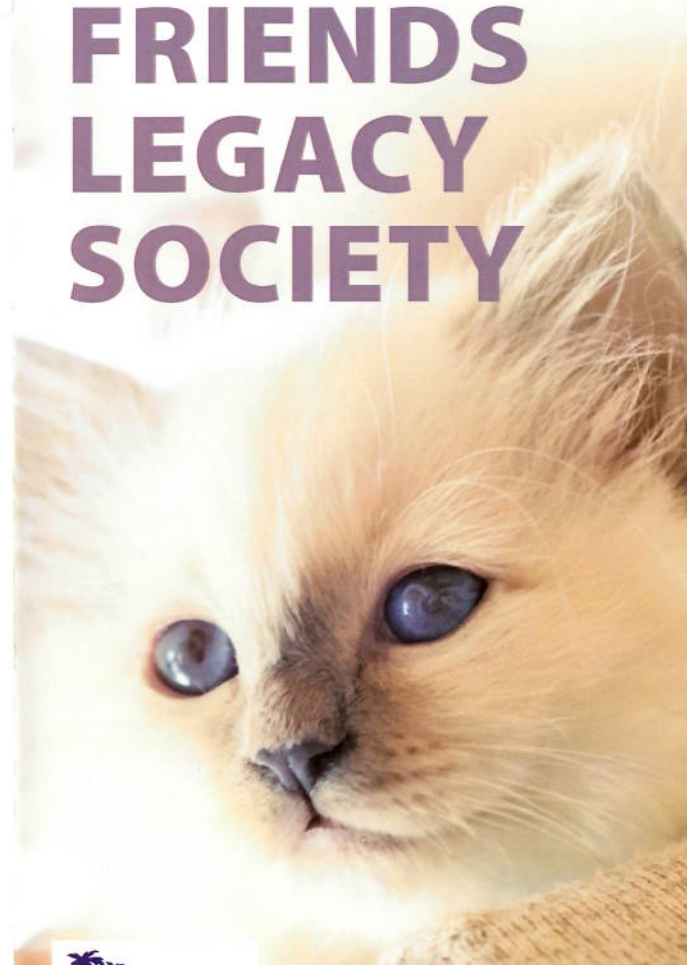
